COUNCIL NOMINEE BIO'S

Roxanne Bowdin - This will be my second term on the Council and I look forward to serving Zion once again. I've held the position of president this past year and secretary prior to that. I've been a member of Zion for more than 20 years and have also served on the Missional Planning, Stewardship, Personnel, and Nominating committees. My husband, John, and I live in the Town of Peshtigo and our son and daughter-in-law reside in California. I've retired from teaching at NWTC and am enjoying every minute.

<u>Chad Richard Francour</u>. I am currently a substitute teacher for the school district of Marinette. I have been a member of Zion Lutheran church for 27 years, being baptized as an infant. My mother's name is Lynn Francour and my father's name is David Francour. I have a sister, Angie Rohland, who is 33 years of age and a brother, Ryan Francour, who is 30 years of age. I am 27 years of age and finally; my sister, Katie Francour, is 21 years of age.

Report of the Pastor for 2014

In John's Gospel, Chapter 1, we hear Philip inviting what we assume to be his friend, Nathanael, to meet Jesus. Philip is pretty excited. He says, "We have found him whom Moses in the law and also the prophets wrote." Nathanael seems less than enthused when he finds out that this person they found is from Nazareth, saying, "Can anything good come out of Nazareth?" Philip is undeterred by Nathanael's doubt and simply says, "Come and see."

What Philip doesn't say is just as important as what he did say. Philip didn't say, "Come and learn." He didn't say, "Come and hear," even though there would be much that they would hear from Jesus. He didn't say, "Come and get busy. Join a committee. Grab a paintbrush." Again, this is important because, indeed, they would get busy, working with Jesus to heal a broken world. Philip simply said, "Come and see," because that's where it starts. That is the beginning. We first come to faith by simply seeing Jesus in action.

This Annual Report is filled with details about how Jesus was in action within and through our congregation. Yes, it takes the form of hearing and learning. It takes the form of getting busy and working with others to make a difference. It does indeed look like the things that Philip did not say, but the goal is the same. This ministry that we do, a ministry that is seen by others, we do in order to help people come to faith, grow in faith, or deepen in faith. We do it to be God's love in the world. We do it so that people can come and see Jesus, something we have done for over 139 years, just as Nathanael did so many years before us.

So, what was there to see?

Prav

We envision a congregation that prays regularly and embraces prayer as being central to all that it does and habitually listens for God's call and guidance, not only in all areas of congregational ministry, but in our personal lives as well.

We pray on Sunday mornings. Our musical/visual preludes are designed to help us prayerfully focus on the theme of the day. Our hymns are forms of prayer. We pray throughout the service and we especially pray for one another. Even though all the petitions we share take some time to go through, I believe they make up a vital part of our worship and our encouragement of one another. This is something we do. We pray for our world, for the ministries that are important to us, and for one another. People can see this when they worship with us.

Our praying as a congregation is particularly evident in our Sunday Evening Service of Reflection. Using silence, we take a lot of time in that service to really listen for God, something that we don't have as much time for in our Sunday morning or Thursday evening services. Prayer is as much listening as it is speaking. People can see us actively listening on Sunday evenings.

We also were actively listening during our Lenten Prayer Journey, not just when we gathered as a community but also at home. The Lost and Found Parables in Luke's Gospel were our focus this year. These parables guided our prayer, helping us hear God speaking to us in new ways.

I am so moved when others step up and lead the prayers that begin our committee meetings or our gatherings. Sure, I can do it, and enjoy doing it, but for me it means so much more when those who are not "the hired gun" step up and perform this ministry. It seems to be happening more and more lately, and I couldn't be more pleased. It is a good thing for people to see.

Worship

We envision a congregation that worships enthusiastically and is so hungry to praise and worship God that at least half of its baptized members are present for worship on a weekly basis.

So, what do people see when we worship? Certainly people see enthusiasm in our worship. People also see the dedication of worshippers on Sundays like the Sunday after Christmas, New Years or Easter, or on Sundays when the weather is terrible, like we experienced often during the winter of 2014. People can see that worship is important to us. It is the central reason for our gathering. Yes, we gather for so many other reasons, like education and mission in the world, but worship is our primary reason for gathering as a congregation. Nothing else is more important.

Am I concerned that worship attendance took a significant dip in 2014? Yes. Alarmed? No. I trust that God is still active and busy within our midst. We still have this vision of half our members present for worship on a given Sunday and I think we will be taking further steps in 2015 directing ourselves toward that vision.

So, what would our vision look like? A worship attendance of around 200 on a weekend would be pretty close to 50%. At a present average of 113, we have some distance to go. Maybe in 2015 we might challenge one another to attend on a particular Sunday trying to make our 50% goal or for a group of Sundays. We had 159 in worship the weekend on of Consecration Sunday. That was 40%, AND it wasn't a Christmas Eve where a large number of visitors skew the percentage. People see worship attendance.

I have heard a few concerns about the length of Sunday morning worship. On the one hand, I understand the concern. Time is an extremely precious commodity. For many, it is more valuable than money. Surely time constraint is one of the reasons people are not able to worship more regularly. They cannot afford the time. On the other hand, we usually want more time with our best friends and the ones we love. Jesus is certainly our best friend, and worship offers a unique and powerful way to be with Jesus. Why would we want to rush away from that precious time together? I will be in conversation about this with both our Evangelism Committee and our Worship and Music Committee and will be exploring some minor tweaks during the upcoming months. I realize that it will never be short enough for some and for others going over an hour is seen as a bonus. That's the fun of working together as a family, and people do see how we work together.

Study

We envision a congregation that studies the Holy Scriptures and the principles of Christian faith in order to fulfill its great desire to learn more about its calling as disciples of Jesus and the gifts that God so graciously provides. Families will regularly use materials provided for Bible study

at home, and groups within the congregation will regularly gather to study the Scriptures and these principles.

I am so very pleased with the education we offer our young people though SPARK, first communion classes, Vacation Bible School, and Confirmation. We have lots of dedicated people working hard to make a difference in the lives of these young people so that they not only learn information about Jesus and the Bible and life as a Christian, but they also practice Christian community and service.

I am also pleased that most of our devotional books for families and for adults are being used. I would love to experience the need to order more, but I'm so glad that I don't have to reduce our orders. I would like to see more subscriptions to the Lutheran. This magazine not only gives us a picture of what is going on within other congregations of our denomination, but it also provides lots of help and support for spiritual growth. At \$8.95, it just doesn't cost that much, and even if each and every magazine do not get read, the super low price still makes it worthwhile when it does get read.

Educational opportunities for adults in 2014 included a regular Bible study on Tuesday mornings at St. James, with the same Bible study held at Zion on Wednesday evenings. This fall the theme of that study has been prayer. During Lent, a study called Contemplating Death was offered at St. James on Tuesday mornings. Also during Lent, on Sunday mornings following worship as well as following worship on Thursday evenings, people gathered together for the Lenten Prayer Journey. Unfortunately, that was the only Sunday morning study that occurred in 2014. Our Women's Circles, Sarah and Ruth, continue to have study as a vital part of their gatherings. There is also another gathering of women who study the Bible once a month.

Our Conference will no longer hold the Synod's Lay School for mission, but the pastors will be offering classes through out the year that are open to people from the various congregations in our Conference. These classes are held on Monday evenings during the school year. People of other denominations are also attending.

In January and February, Zion held a Dave Ramsey Financial Peace University series of classes. These were well attended and once again the participants gave glowing reviews of the classes. It is our hope that we will offer these classes again.

We never arrive when it comes to these Marks of Discipleship. Therefore, it is tempting to wring hands and say that so much more needs to happen. And, so much more could happen, particularly in the area of study. This continually challenges me, and yet, as we can see, there is a lot that we offer for study and many are availing themselves of these opportunities. This is something that people can see, and I'm grateful.

Invite

We envision a congregation that invites others to participate in the life of the congregation by training its members to actively encourage those who are not connected with a congregation to participate in what Jesus is doing through Zion, warmly welcoming them and enthusiastically involving them in the mission work we do together as God's children.

Inherent within the call of Philip, noted at the beginning of this report, to "come and see," is the invitation. Inviting others is part of the Jesus' Great Commission at the end of Matthew's Gospel, chapter 28, where he says, "Go therefore, and make disciples of all nations." This assumes that we, as his disciples, will never tire of inviting others to participate.

This part of our Vision Statement is closely replicated in the Mission Statement of our Evangelism Committee.

"Following Jesus' lead, Zion's Evangelism Committee will encourage, enable, and empower God's children of Zion to embrace their calling to be evangels through the ministry of Zion and in daily life."

This is what we are trying to accomplish.

A big project of the Evangelism Committee this past year was creating the Hospitality Video. The theme of this video was about how we should and should not welcome strangers. I was pleased that so many participated with the production of this video, that we had so much fun doing it, AND that the participants embraced what it was trying to communicate. How we welcome strangers in worship, whether they are just here for the day, or are shopping for a congregation, or have been members for years, is a critical part of inviting others to participate with us in the work of Jesus through our congregation. It is difficult to emphasize this enough, because WE all experience Zion as a friendly place. However, not everyone does experience Zion as friendly place, and it has everything to do with our hospitality skills, and those skills are demanded of each and every one of us, not just the extroverts. All of us need to welcome and get to know strangers, no matter who they are. The main reason for this is said best in the book of Hebrews, 13:1, "Do not neglect to show hospitality to strangers, for by doing that some have entertained angels without knowing it."

I think of Amanda, who left our community this year to live in North Carolina. When she came out our congregation, she felt invited by the hospitality we offered within the weddings held at Zion that she worked at as a photographer. She also felt invited because she did not hear any complaining about Zion. This was something she heard a lot of from members of other congregations regarding their congregations. People in the community see our congregation through us! When she worshipped as stranger, Heidi, someone she had once worked with, welcomed her, and through Heidi she met others. Eventually she was baptized became very active within our congregation, and part of her activity was inviting others to worship with her and to work with her in things like the Harvest of Hope Community Garden. This is how it works. Inviting others and the hospitality we offer are critical pieces of helping others see and experience Jesus in our midst.

Encourage

We envision a congregation that encourages and supports its members and others in the community on their faith journeys by regularly organizing groups that will foster Christian fellowship. Zion will also continually grow in the types of caring ministries offered within the congregation.

In 2014 Zion held two Sunday morning services in the style of the Service of Reflection:

March 30 and August 24. One of the many reasons for worshipping in this style is that it pushes us to meet one another, listen to each other's stories and ENCOURAGE one another. Sometimes it is a challenge to meet new people within our congregation so that we can encourage them, and they can encourage us. Offering a setting for that encouragement to take place is at the heart of this service.

Did you know that Don and Julie Otto lead a worship service at The Renaissance once a month? It is a way that Zion's encouragement reaches others in our community. They do it as a part of their work on the Caring Ministry Team. They always say how blessed they feel to be a part of it.

Did you know that Hope Goes regularly attends the Ruth Circle? She's in her senior year of High School, and she joins with women who are well into retirement age. She does this because she feels encouraged by them, and surely they feel encouraged by her. I love it when it works out like that. Don't you?

Did you know that our A.V. Team is made up of both adults and students and that these students and adults work together most of the time? As they visit with one another they are getting to know each other better and through it offer encouragement to one another. I love it when it works out like that. Don't you?

During Soup Suppers we have adults and students working together to put on the meals. We also have strangers meeting one another as they too work to put on these meals. And as they get to know each other, they encourage one another. This is something people can see.

My point: If you aren't yet involved in the congregation in some way, you might want to try something. Yes, it takes some time, and yes, it will sometimes demand patience and understanding, but the benefits of offering and receiving encouragement far outweigh these expenses. Many of these ministries are also ways of expressing Zion's encouragement to others in our community, and the people of our community are watching.

Give

We envision a congregation that gives generously of time, talents, and treasures for the work of Jesus in our community and around the world, and encourages others to be generous with their gifts as well.

After going through three years where our receipts did not reach the level of the previous year, I am so pleased that 2014 was the second year in a row that this did <u>not</u> occur, and our General Fund grew by a modest \$2,250. This is particularly awesome in light of the decrease we've experienced in worship attendance. I can't thank you enough for your great generosity!

In 2014 we completed our second mile campaigns that started with the Capital Campaign back in 2007. We paid off our loan of \$175,000 and did so much more. Again, the generosity of this congregation was awesome! I'm so proud to be a part of it.

In 2015 we will be setting up percentages with our budget that will go toward ministries and our building, replicating what we were doing with our second mile campaigns, but making them a

part of our first mile giving. Therefore, in addition to the 11% that we always gave to the work of the wider church through our Synod, we will also designate 1.1% to directly support the work of Fortune Lake Lutheran Camp, .175 % to support Northland Lutheran Retirement Community, 2% to support DAR Boys and Girls Club, 2% to support community scholarships for Fortune Lake, and 4.5% to go into our Capital Improvements Fund to support the continued maintenance of our building. Just as we ask people to consider first fruits giving on a percentage basis when it comes to their offerings to God's work within our congregation, so too will Zion give all these as first fruits beneficiaries of our regular giving!

Our Stewardship drive in 2014 was Consecration Sunday. It was a drive style that emphasized percentage giving, working our way toward a tithe of 10%. It also emphasized our giving as a form of worship; therefore the pledges we made took place within worship on Consecration Sunday, October 5th. This drive also emphasized how giving and spiritual growth are intimately connected. I am so pleased to turn your attention to the Stewardship report within this Annual Report that shows the results of this drive. Although we had one less person make a commitment this year compared to last year, the amount pledged was over \$32,000 more than the previous year. Wow! The number of people increasing their pledges for 2015 made a huge difference! Thank you! Thank you! Not only will this help Zion grow in mission, but it is also a wonderful sign of spiritual growth within our congregation!! Our generosity is also something that people see.

One person within our congregation that really has a passion for the spiritual aspect of giving is Karen Sylvester. Not only does she help lead the work we do on the Stewardship Committee, but she also writes the Stewardship Corner in our newsletter every month. These articles are always heartfelt and informative, and certainly help and encourage us all to grow in faith through our giving.

Serve

We envision a congregation that serves by employing innovative ways to assist children and their families in our community as well as around the world.

I still think that as a congregation, this Mark of Discipleship is something that we are particularly gifted at. We have many, many signs of this through out the year. Please see the Social Ministry report regarding all the different ways that we serve under their oversight and guidance. One new way that I believe shows us how strong we are in this area occurred late in the summer. At the very last minute we organized a work bee under the ELCA's "God's Work. Our Hands." Campaign. We didn't give advertising much time or effort, and yet we had an awesome number of people who showed up to work! It was wonderful and what a difference we made. That passion to make a difference in our community was something that could be seen!

The Relay for Life is also something we do, as is our work through the Harvest of Hope Community Garden. Recently Colleen Madden, who jumps in the Lake on New Years Day in order to raise money for DAR and the Animal Shelter, posted this on Facebook. *Today...after our church service wrapped up and I was gathering my things...a man that's a long-time member of my church came up to me and said "I just want to thank you in advance for participating in New Years Days Dayooper Plunge. I'd like to give u some \$ to go towards the \$ u collect for the*

Menominee Animal Shelter, my wife and I support MAS too...and this is my rainy day money...."and he handed me a hundred dollar bill. This makes my jumping in the bay on Thursday totally worth while! Praise be to God!! As I said, I think serving is a strength of our congregation and I'm excited to see all the new ways we're going to come up with in the years ahead to grow in this serving. This is something people can see.

Vision

Our Vision Statement is filled with lofty goals that we may never reach, but, as we all know, it's not the goal; it's the journey. The goal shows us where we are going, but the journey is where we live. This Vision Statement describes what we hope to see along the way and what we hope others will see as well.

When Nathaniel came and saw what Philip was talking about, when he met Jesus, he came to faith in very powerful way, proclaiming, surely with tears in his eyes, "you are the Son of God! You are the King of Israel!" That's what can happen when we invite people to join with us. That's what can happen when we attend to the goals within our Vision Statement. These are the things that people see and the precious gift of faith is the result.

I am still so very grateful to be called your pastor. In 2015, I will celebrate 30 years of being an ordained pastor, 17 years of which I have been blessed to serve here. I never imagined being so blessed 30 years ago. You make it a joy to be engaged in ministry with you, and I can't thank you enough. Your support for my family and me means the world to me. Again, thank you!

Zion's Caring Ministry Team

Zion's Caring Ministry Team (ZCMT) is comprised of people who want to provide quality, Christ-centered, confidential care to those in our congregation who are elderly, home-bound, in a nursing home or assisted living, and those who are lonely.

ZCMT comprises five components; Holy Communion distribution, visiting the elderly/home-bound, a card ministry, handling small household tasks for the elderly, and meeting transportation needs.

Heidi Beland, Julie and Don Otto, Pat Rondeau, Sarge Rudell, and I have distributed Holy Communion at least monthly to as many as nineteen individuals. This year, 113 communion visitations were made. Julie and Don Otto minister at Renaissance with as many as fourteen people on any given Sunday; three are members of Zion the rest are not. Each of us holds a short worship service; some share sermon notes taken the Sunday before the visit; some sing songs, some do not. Each of us feels blessed by God to be able to provide this ministry to his flock.

Ninety-seven visits were made to twelve congregation members, most monthly. The 2014 team members were John Bowdin, Ann Buscher, Lori Despins, Hope Goes, Jacki Renne and me. Most of the individuals we visit don't have an opportunity to leave home very often. A few reside in their own home; however, the majority are in assisted living or a nursing home. Earlier this year, John Bowdin resigned as a member of the group. I want to thank John for his help and wish him well in whatever he might pursue.

Zion's card ministry is spearheaded by Nancy Sallee who has reached out and touched so many of Zion's members with a variety of beautifully caring greeting cards. Nancy's goal is to bring a little of Gods love and caring into lives. Even though Nancy and Kenny are "snowbirds" Nancy asked to continue her ministry and for that we are very thankful.

On occasion, the Caring Ministry Team has been asked to help an elderly person with a special task in their home which they are not capable of handling themselves. These types of requests don't come often, but when they do we try our best to fill them.

Several members of the team provide transportation to members of Zion when needed; usually to worship but sometimes for medical appointments and to help meet other needs.

Sanctuary Arts

The Sanctuary Arts group was charged with looking at Zion's sanctuary to consider how the worship experience could be enhanced through color, decorating and design.

The first meeting of the Sanctuary Arts group was held June 5, 2014. An extensive wish list of short and long term (pie in the sky) projects was developed. These included categorizing and labeling the paraments and banners by seasons, removing altar greenery, plastering and painting concrete walls, removing the curtain behind the cross, lighting improvements, carpet replacement, moving the altar forward, moving the communion rail to ground level, removing the lectern to provide the worship band additional room, and angling the pews.

In 2014, the Sanctuary Arts group removed the greenery at the altar, sorted through all the banners to see what should be kept, repaired, or repurposed; those kept were labeled by season. All paraments were labeled, and the sanctuary was decorated for Pentecost and Thanksgiving.

It was decided lighting was the top priority over other sanctuary design modifications. The reason, the vast majority of Zion's interior fixtures use T-12 fluorescent bulbs which are outlawed and must be replaced with T-8 bulbs. Additionally, the group felt Zion's exterior lighting creates a safety hazard especially at night for the elderly. Lighting information was gathered and turned over to the Church Council. While they approved the project they felt additional information should be obtained. Gary Grom, Kathy Heimbuch, Gary Houdek, Pastor Keith, and Scott Williams volunteered to actively pursue this much needed improvement. This project should be underway in 2015.

We are still in need of a few men to share responsibility for placing and removing the cloth on the cross at appropriate times during the church year. The current schedule is: Ash Wednesday – purple cloth, Good Friday – black, Easter – white, and Pentecost – red.

Our goal is to inform and uplift God's people about the true definition of stewardship and we hope we have done that. The 2014 articles covered a variety of topics including our inability to out-give God, the correlation between faith and contributions, worship attendance and giving, how generosity and gratitude define stewardship, the homeless and "The Closet" at Marinette High School, how to be good stewards of the earth, finding balance between needs and wants, what percentage is enough for Zion to give to its missions, plus a few more topics.

This year, Zion's Fall Stewardship Drive was called Consecration Sunday – a copyrighted program used for many years in countless congregations. The program teaches stewardship on the basis of the giver's need to give for his or her own spiritual benefit rather than on the basis of the need of the congregation. By concentrating on tithing and percentage giving, the emphasis turns out to be a spiritual growth experience.

Since 2010 there have been two parts to our pledge drive, the first and second mile campaigns. In 2015 that will change. To start us thinking about percentage giving, Pastor Keith evaluated Zion's level of percentage giving to its missions and the church at large. This information was provided through the monthly newsletter. The week before Consecration Sunday, we learned about our congregation's giving patterns, how many households give how much per week, and we were invited to grow one step in that giving in 2015.

By shifting the stewardship emphasis to growing in faith through percentage giving, the amount pledged for 2015 was about \$32,000 higher than in 2014. The average pledge amounted to \$2,104 while it was only \$1,669 in 2014. The most startling piece of data though is that 41 households increased their pledge for 2015 versus only 19 in 2014. If you are interested in additional information on this year's drive, the next page contains a full report compiled by Karen Houdek, Zion's Financial Secretary.

To be the joy-filled event it was, Consecration Sunday required a lot of people's help. Pastor Craig Mansur served as guest leader, Council members made phone calls, Hilma Backman, Dave Johnson, and Heidi Beland provided Temple Talks, Michelle Larson and George Olson provided floral centerpieces, Judy Stehle served as the Celebration Brunch Chairperson, the men from Bethel Lutheran provided a delicious brunch, and this committee was responsible for cleanup. Thank you to all of you who gave so generously of your time, and for all those who attended the event. We could not have done this without you, and we are deeply appreciative.

As we stated earlier, the goal of Zion's stewardship ministry is to help God's people grow in their relationship with Jesus through the use of the time, talents, and finances God has entrusted to them. With God's help and guidance we hope we are accomplishing this goal.

 - It is Resolved, that this congregation, at a duly called meeting on January 25, 2015, hereby designate this bequest of \$157,000 as the initial gift for the Mission Endowment Fund, and

Permanent Resolution to Establish The Mission Endowment Fund of Zion Lutheran Church Marinette, Wisconsin

Whereas, Christian stewardship involves the faithful management of all the gifts God has given to humankind - the created world, the Gospel, life, time, abilities, money, including accumulated, inherited, and appreciated resources; and,

Whereas, the biblical principle of proportionate giving, to return to the Lord a portion of the gifts God has first given to his beloved children, is both a privilege and an appropriate response in all times and circumstances; and,

Whereas, Christians can give to the work of the church through gifts in and from wills, life insurance policies, charitable gift annuities, charitable remainder and other trusts, and transfers of property such as cash, stocks, bonds and real estate; and,

Whereas, it is the desire of Zion Lutheran Church (herein referred to as Congregation) to encourage, receive and administer these gifts in a manner consistent with the loyalty and devotion to our Lord in accord with the policies of this congregation, now,

It is Resolved, that this Congregation, at a duly called meeting on January 25, 2015, hereby establishes a new and separate fund to be known as The Mission Endowment Fund of Zion Lutheran Church, (herein referred to as Fund), and,

It is Further Resolved, that the purpose of this Fund is to enhance the mission outreach of Zion Lutheran Church apart from the general operation of the Congregation so that no portion of the distributions of the Fund shall be used for the annual operating budget of the Congregation, and,

It is Further Resolved, that the Mission Endowment Fund Committee (herein referred to as Committee) shall be the custodian of the Fund, and,

It is Further Resolved, that the purpose, governance, administration and management of the Fund and Committee are established and defined by the plan of operation as hereinafter set forth.

Plan of Operation

Committee Membership

The Committee shall consist of five (5) members, all of whom shall be voting members of Zion Lutheran Church. Except as herein limited, the term of each member shall be three (3) years. Upon adoption of this resolution by the Congregation, it shall elect five (5) members to the Committee: two (2) for a term of three (3) years; two (2) for a term of two (2) years; and one (1) for a term of one (1) year. Thereafter, at each annual meeting, the Congregation shall elect the necessary number for a term of three (3) years. No member shall serve more than two (2) consecutive three (3) year terms. After a lapse of one (1) year, a former Committee member may be re-elected. The Pastor and the President of the Congregation Council shall be advisory members of the Committee.

The Congregation Council shall provide for the nomination of potential members of the Committee and report same to the annual congregation meeting in the same manner as for other offices and committees. In the event of a vacancy on the Committee, the Congregation Council shall appoint a congregation member to fill the vacancy until the next annual meeting of the Congregation, at which time the Congregation shall elect a member to fill the term of the vacancy.

The Committee shall meet at least semi-annually, or more frequently as deemed necessary by it in the best interest of the Fund. A quorum shall consist of three (3) members. When only three (3) members are present a unanimous vote shall be required to carry any motion or resolution.

The Committee shall elect from its membership a chairperson, recording secretary and treasurer. The chairperson, or member designated by the chairperson, shall preside at all committee meetings. The recording secretary of the Committee shall maintain complete and accurate minutes of all meetings and supply a copy to each member of the committee. The recording secretary shall also maintain and oversee the records of all minutes of the Committee, in order to supply records upon request. The recording secretary shall also supply in a timely manner a copy of the minutes to the Congregation Council.

The treasurer of the Committee shall work with the Congregation's financial secretary and/or treasurer in maintaining and coordinating complete and accurate accounts

for the Fund. The treasurer of the Committee and one other Committee member shall sign checks and all other necessary documents on behalf of the Congregation in furtherance of the purposes of the Fund. The financial records of the Committee shall be audited annually by a certified public accountant, the congregation's audit committee, or other appropriate person who is not a member of the Committee. The Committee shall report on a semi-annual basis to the Congregation Council. Further, at each annual meeting of the Congregation, the chairperson of the Committee shall render a full and complete account of the administration of the Fund during the preceding year.

The Committee may request other members of the Congregation to serve as advisory members and, at the expense of the Fund, may provide for such professional counseling on investments or legal matters as it deems to be in the best interest of the Fund.

Members of the Committee shall not be liable for any losses which may be incurred upon the investments of the assets of the Fund except to the extent such losses shall have been caused by bad faith. No member shall be personally liable as long as he or she acts in good faith. Each member shall be liable only for his or her own willful misconduct or omissions, and shall not be liable for the acts or omissions of any other member. No member shall engage in any "self dealing" or transactions with the Fund in which the member has direct or indirect financial interest, and shall at all times refrain from any conduct in which his or her personal interests would conflict with the interest of the Fund.

Decisions to hold, sell, exchange, rent, lease, transfer, convert, invest, reinvest and in all other respects to manage and control the assets of the Fund (including stocks, bonds, mutual funds, debentures, real estate, mortgages, notes or other securities) shall be made at the discretion of the Committee. However, the Congregation Council shall approve each decision/transaction involving an amount in excess of 50% of the value of the fund. The Fund assets shall not be used for loans. Members of the Committee shall be bonded under the Congregation's insurance policy.

Defining Principal and Income

The Committee shall determine what is principal and income, and shall have the discretion to include all appreciation of the assets of the fund within the definition of income.

The Fund shall accumulate until a principal amount of \$25,000.00 is achieved, after which 3-8 % of the assets of the Fund shall be distributed annually according to the distribution formula below. In no event shall annual distributions reduce the Fund balance below \$25,000. The distribution percent shall follow as nearly as reasonable the distribution recommended by the advisors of the ELCA Endowment Pooled Trust Fund.

The current distribution percent, based on a 5 year rolling average of interest and growth with inflation and 1% annual fund management expense considered, is 4.5%. The Mission Endowment Committee is free to select whatever percent is prudent. While there is no assurance that the recommended percent will not reduce principal value, higher percentages than recommended has a greater probability, in poor economic conditions, to erode the principal.

Distributions

Income from the Fund shall be distributed annually, or at such other times as is deemed necessary or feasible to accomplish its purposes through the following distributions:

A. Ten to thirty-five (10-35%) percent for outreach into the community and synod, including, but not limited to, grants to Evangelical Lutheran Church in America seminaries, colleges or students attending such institutions, social service agencies, institutions and agencies to which this Congregation relates, and to special programs designed for those persons in our parish area who are in spiritual and/or economic need.

- B. Ten to thirty-five (10-35%) percent for missions of the Evangelical Lutheran Church in America, nationally and worldwide, including, but not limited to, grants to the Evangelical Lutheran Church in America for new congregation development, professional leadership, educational ministries, global mission, ecumenism, evangelism, social ministries, disaster response and capital financing.
- C. Up to thirty-five (0-35%) percent for capital improvements, debt reduction for a building program, or for the development of any special ministry of the Congregation.
- D. Up to twenty-five (0-25%) percent for any one or all of the above designated areas in any proportion as determined by the Committee, or for causes and programs which at the discretion of the Committee are deemed consistent with the purpose of the Fund in enhancing the missional outreach of the Congregation.

The Committee shall determine both the percentage of available funds per category to be distributed annually and the recipients of the annual distribution within any category. Such determinations of the Committee shall be approved by the Congregation Council prior to the disbursement of funds.

When a gift originally in excess of \$25,000 has remained in the fund for 30 years, the Committee may distribute the remaining principal of the gift pursuant to the rules applicable to annual distributions. Such a distribution may be made only in an amount that it does not reduce the fund assets below 50% of its pre-distribution value. The determination of what constitutes the balance of an "aged gift" shall be within the sole discretion of the Committee.

Emergency Distributions

A. When, in the unanimous opinion of the Committee, there is a need so great of one of the recipients in one of the categories of distribution that Christian compassion and stewardship requires a distribution greater than available under the previous distribution provisions of this plan, the Committee, with the prior approval of the Congregation Council, may distribute up to 5% of the Fund to such need.

B. When, in the opinion of the Committee and the Congregation Council, circumstances are so dire and of such an emergency nature that the future of the congregation is at stake, and that the only recourse seems to be the use of the Fund principal beyond any portion distributable under the foregoing provisions, the Committee may, upon a unanimous vote of both the Committee and the Congregation Council, recommend such authorizing action to the Congregation. Such an emergency distribution of principal shall require a two-thirds (2/3s) vote of the members present at a duly convened meeting of the Congregation.

Amending of Resolution

Be it further resolved, that any amendment to this resolution which will change, alter or amend the purpose for which the Fund is established, and/or its distributions, shall be adopted by a two-thirds (2/3s) vote of the members present at an annual meeting of the

Congregation, or at a special meeting of the Congregation called specifically for the purpose of amending this resolution.

Disposition or Transfer of Fund

In the event Zion Lutheran Church ceases to exist either through merger or dissolution, disposition or transfer of the Fund shall be at the discretion of the Congregation Council in conformity with the Congregation Constitution and Bylaws, and in consultation with the Bishop of the Synod of the Evangelical Lutheran Church in America to which this congregation belongs.

Designated Gifts

The Mission Endowment Committee encourages undesignated gifts. Should a donor wish to designate their gift to a specific need or ministry, the Mission Endowment Committee (MEC) requests that the committee be informed in writing of the designation prior to receiving the gift. Further, the MEC reserves the right to clarify the designation with the donor and not accept gifts that do not comply with the mission or purpose statement of the congregation. Gifts to a designated fund will be independently accounted for and will be separate from all other endowment funds.

Adoption of Resolution

This resolution, recommended by the Congregation Council and considered by the Congregation at a duly convened meeting, is hereby adopted this 25th day of January, 2015.

Greetings in the Name of Jesus:

Your synod has a vision! We are to be a Church of "Worship, Witness, and Welcome." As we remind ourselves of this truth, the synod is focused like a "laser beam" on these powerful themes in the years 2014-2016. Let's see how much we know about our synod and our church as you answer the following. Are the following ten "Worship, Witness, Welcome" statements true or false?

We have almost 100 members who consider themselves to be American Indians. 7. True. Twenty congregations worked on this ELCA project last year and forty more want to this year. 8. True. 9. False. Sixty one of our congregations have Sunday School. 10. True. Eight pastors in the last dozen years have been raised as sons and daughters of First Lutheran in Gladstone!

We are in a time of considerable change in our communities and our churches. In the next decade it will be determined whether our congregations will be positioned to grow again or whether we will decline. Is there a leadership group in your parish that is thinking and planning for the future? How will we face the changes that are confronting us? Are we working to make our churches more attractive to people who have had little connection with the word of God?

We are on quite an adventure! The synod continues to strive to equip your congregation for mission and ministry.
